**QUALIFICATIONS FOR CANDIDATURE**

To be qualified to be elected a member of a community council a person must be 18 years of age or over at the date of his or her nomination, and a Commonwealth citizen, a citizen of the Republic of Ireland, or a citizen of another Member State of the European Community, and either:-

- (i) be a local government elector of the community; or
- (ii) have during the whole of the twelve months preceding the day on which he or she is nominated as a candidate occupied as owner or tenant any land or other premises in the community; or
- (iii) his or her principle or only place of work in the twelve months preceding the day on which he or she is nominated as a candidate has been in the area of the community; or
- (iv) have resided either in the community or within 4.8 kilometres thereof during the whole of the twelve months preceding the day on which he or she is nominated as a candidate.

1. An Election is to be held for **TWO** Community Councillors for the **EAST WARD OF NEYLAND TOWN COUNCIL**.
2. Forms of nomination paper may be obtained from the **ELECTORAL SERVICES OFFICE, CHERRY GROVE, HAVERFORDWEST, SA61 2NZ**.
3. Nomination papers must be delivered to the **RETURNING OFFICER, ELECTORAL SERVICES OFFICE, CHERRY GROVE, HAVERFORDWEST, SA61 2NZ** on any day after the date of this Notice, but no later than **4.00PM** on **FRIDAY 29<sup>th</sup> SEPTEMBER 2017**.
4. If the Election is contested, the poll will take place on the **26<sup>th</sup> day of OCTOBER 2017**.
5. Alterations to existing arrangements for postal voting by electors or their proxies who already have an indefinite or fixed period postal vote, or new postal vote applications, must reach the **ELECTORAL REGISTRATION OFFICER, ELECTORAL SERVICES, CHERRY GROVE, HAVERFORDWEST, SA61 2NZ**, by no later than **5.00pm** on **WEDNESDAY 11<sup>th</sup> OCTOBER 2017**.
6. Applications to vote by proxy must reach the **ELECTORAL REGISTRATION OFFICER** by no later than **5.00pm** on **WEDNESDAY 18<sup>th</sup> OCTOBER 2017**.
